D-Link Reports Fourth Quarter 2021 Financial Results


Taipei, March 29, 2022- D-Link today announced its net revenue of NT\$4,301 million for the fourth guarter 2021, an increase of 3.5% YoY; Gross profit was NT\$996 million, a decrease of 23.5% YoY; Operating income which reported at NT\$45 million, an increase of 45.2% YoY. D-Link's fourth quarter net income was NT\$442 million, net income attributable to owners of parent was NT\$425 million, and EPS was NT\$0.71 per share.

With respect to 4Q21 consolidated revenue by product category, Switch & Security products accounted for 36% of sales revenue, followed by Wireless & IoT at 23%, Mobile & Broadband at 16%, and Others at 25%. From a geographic perspective, 4Q21 revenue contribution from Europe and America were 32% and 9% respectively, and from Asia Pacific & Others was 59%.
